The inaugural Clays for a Cause Clay Shoot was held April 1. And June 10 we hosted the Inaugural Pork & Cork at the Showroom at Five Points. In September, we hosted our 33rd annual The Classic golf tournament at Egwani Farm. We had another record-breaking year by netting over \$63,000 and had over 40 total golf teams, which is an increase of 10 teams over the previous year!

Just days after the golf event, the Foundation moved and is now located in the Blount Memorial Financial Operations Center (FOC) building in Downtown Maryville. Our new location provides us with increased public visibility and tons more space. Our new Downtown Maryville neighbors have been very welcoming and are excited to partner with us on fundraising activities!

The 2022 fundraising year concluded with the wonderful Holiday Tree of Lights campaign in December. Many family and friends supported the fundraiser by providing honoraria and memorials for loved ones. All funds raised support the General Fund while providing beautiful Christmas lights on our tree for the community to enjoy.

We continue to be blessed throughout the year to receive donations for our Cancer Patient Resource Fund, Hospice and Palliative Mercy Fund, and Pediatric Rehabilitation.

Who We Are

In 1989, Blount Memorial Foundation was established as a 501(c)3 organization to serve as the development arm of Blount Memorial Hospital. For 33 years, the Foundation has provided financial support to improve the health and well-being of our community. We fund our mission by hosting events; making targeted requests; applying for local, state, and federal grants; as well as partnering with local organizations who share our mission.

The Foundation supports patients within the service area of Blount Memorial Hospital, primarily Blount, Loudon and Monroe counties.

Last year, the Hospital provided over \$41.3 million in uncompensated care to our community, demonstrating the growing number of uninsured and under-insured individuals. While Blount Memorial Foundation does not pay for medical treatment, we work in partnership with the Hospital to improve health outcomes and meet our community's needs by providing financial assistance with everyday expenses (food, rent, utilities, transportation costs, prescriptions, etc.) for qualified patients. The Foundation also helps raise funds for urgently needed equipment or supplies that improve patient comfort, care, and treatment outcomes.

Because the Hospital covers all daily Foundation overhead, 100% of the contributions received go directly toward our community's most urgent healthcare needs.

How We Helped in 2022

Blount Memorial Foundation was created in 1989 to assist patients of Blount Memorial Hospital through direct patient financial assistance or assisting the Hospital with equipment purchases to improve patient comfort and promote healthy outcomes. Multiple funds were created within the Foundation to meet the various assistance needed. These funds provide donors the opportunity to direct their gifts to a specific need or assistance program.

Cancer Center Patient Resource Fund

This important program provides transportation to chemotherapy or radiation therapy and essential expenses for eligible patients.

Garden Of Life

Individuals can memorialize or honor a person or organization by funding an engraved brick, a tree and marker, or a dedicated bench in our peaceful oasis, the Garden of Life. Proceeds from the bricks benefit the Family Birthing Center.

Healthy Heart Fund

Funds for this program improve cardiovascular health of eligible patients by providing scales for home use, financial assistance for essential medications, and scholarships for the Medical Fitness Center. An eligible patient recovering from surgery or cardiac symptoms may qualify for a fitness program designed to build a healthier heart through supervised exercise directed by specialized cardiac rehabilitation staff.

Palliative Care And Hospice Mercy Fund

Contributions to this fund aid patients and families who need assistance but have limited financial resources by providing food and hospice packets (hospital bed sheets, blanket, gowns and pads). Your gift also provides background checks to those volunteers with the No One Dies Alone (NODA) program. NODA provides volunteers to sit with and comfort the hospitalized patient when the family is unable to be there.

General Fund

The fund assists with specially-designated activities to benefit eligible patients in need. This funding is not used for Foundation overhead or personnel costs. This fund is used to assist patients discharging with home health equipment, clothing for patients, prescription assistance, and other requested assistance. This fund also provides hospital equipment needed to improve patient outcomes and comfort.



2022 Funds

Blount Memorial Foundation uses the funds it raises to provide assistance to the patients of Blount Memorial Hospital and to improve patient outcomes.

Nearly 590 patients were assisted through our Cancer Center Patient Resource Fund, Healthy Heart Fund, Hospice Mercy Fund, and General Fund. All assistance was made possible by the generous donations from you!

Cancer Center Patient Resource Fund

- Gas cards totaling **\$5,120** to assist with transportation to and from cancer treatments.
- Patients received a total of 7,104 ounces of nutritional supplements. (Boost/Ensure)

Cancer Fund assistance continued

- Provided \$799.55 in assistance for utilities
- Provided 252 meals through the Kroger gift card program.
- Assisted 4 patients with prescriptions

Restricted gifts for cancer patients

- A physician provided a donation to purchase Boost samples for cancer patients.
- A grateful patient provided a donation to purchase gift cards for wigs for eligible cancer patients

At the end of October 2022, Blount Memorial Foundation expanded assistance to Hospice patients.

As part of the Hospice Mercy Fund assistance, the Foundation now provides food for patients and their families who are in need.

The Foundation also created Hospice Packets that include 2 sets of hospital sheets, a blanket, 5 gowns, and 5 bed pads for patients who would otherwise go without these items.


The Employee Care Fund






